Also it is registered for the Income Tax exemption under the Income Tax Act 80G. Donations to Regenboog India Foundation is eligible for tax deductions U/S 80-G of the Income Tax Act vide DIT(E) No.2(1005)06-07 dated 16-01- 2008 read with amendment made to Sec. 80-G by Finance Act 2009 with effect from 01-10-2009.

These above mentioned permissions should be revalidated before 30 June 2021 as per the new guidance of the finance act.

Regenboog India Foundation is registered under the Foreign Contribution Regulation Act 1974 to receive the donations from abroad for our projects and our FCRA Registration number: 076080146 and it is valid till 31st October 2021.
